PLANTING NOTES

1. ALL DISTURBED AREAS SHALL RECEIVE 6" TOPSOIL MINIMUM AND SHALL BE FINE GRADED AND SEEDED PER THE SEED SCHEDULE ON THIS PLAN.
2. TOPSOIL AND ORGANIC MATERIAL SOURCES MUST BE APPROVED BY THE OWNER'S REPRESENTATIVE.
3. SOIL MIX SHALL HAVE A PH RANGE OF 5.0 TO 7.0.
4. HAVE SOIL MIX TESTED BY AN APPROVED HORTICULTURAL TESTING LAB. ADD RECOMMENDED ORGANIC SLOW RELEASE FERTILIZERS AS REQUIRED AT THE RECOMMENDED RATES.
5. NO PHOSPHOROUS SHALL BE USED AT PLANTING TIME UNLESS THE SOIL TESTS SPECIFICALLY INDICATE A PHOSPHOROUS DEFICIENCY THAT IS HARMFUL, OR WILL PREVENT NEW LAWNS AND PLANTINGS FROM ESTABLISHING PROPERLY.
6. IF SOIL TESTS INDICATE A PHOSPHOROUS DEFICIENCY THAT WILL IMPACT PLANT AND LAWN ESTABLISHMENT, PHOSPHOROUS SHALL BE APPLIED AT THE MINIMUM RECOMMENDED LEVEL PRESCRIBED IN THE SOIL TEST FOLLOWING ALL NYS DEC REGULATIONS.
7. ALL BED CONFIGURATIONS AND LAYOUT OF ALL PLANT MATERIAL SHALL APPROVED BY THE OWNER'S REPRESENTATIVE PRIOR TO PLANTING.
8. ALL PLANTS MUST MEET OR EXCEED THE STANDARDS OUTLINED IN THE CURRENT EDITION OF ANSI Z280.1, THE AMERICAN STANDARD FOR NURSERY STOCK.
9. PLANTING MEDIUM SHALL BE COMPRISED OF 3 PARTS APPROVED TOPSOIL AND 1 PART APPROVED AGED COMPOST BY VOLUME. PLANTING MEDIUM SHALL BE THOROUGHLY BLENDED PRIOR TO PLACEMENT.
10. ALL PLANTING BEDS SHALL RECEIVE 3" OF DOUBLE GROUND SHREDDED HARDWOOD BARK MULCH.
11. ALL PLANTS SHALL BE MAINTAINED AND GUARANTEED FOR A PERIOD OF ONE YEAR FROM THE DATE OF ACCEPTANCE BY THE OWNER.
12. ALL SEEDED AREAS SHALL BE MAINTAINED AND WATERED UNTIL A HEALTHY STAND OF GRASS, FREE OF WEEDS, IS ESTABLISHED AND (3) MOWINGS HAVE BEEN COMPLETED.
13. THE CONTRACTOR SHALL COORDINATE WITH UTILITY AGENCIES TO VERIFY THE LOCATION OF ALL UNDERGROUND UTILITIES PRIOR TO COMMENCING PLANTING OPERATIONS.

TEMPORARY SEEDING NOTES:

1. TEMPORARILY STABILIZE DISTURBED AREAS OF THE SITE WHEREVER ESTABLISHMENT OF PERMANENT COVER IS NOT FEASIBLE UNTIL A LATER DATE. SEED ALL CUT AND FILL AREAS, TOPSOIL PILES AND PONDS WITHIN SEVEN (7) DAYS AFTER COMPLETION.
2. IF SOILS ARE COMPACTED, SCARIFY UPPER TWO INCHES BY BACKBLADING, RAKING, OR LIGHTLY DISKING.
3. ALL SOILS SHALL BE TESTED BY AN APPROVED HORTICULTURAL TESTING LAB. ADD RECOMMENDED ORGANIC SLOW RELEASE FERTILIZERS AS REQUIRED AT THE RECOMMENDED RATES.
4. SEED WITH THE FOLLOWING MIX:  
SPRING/SUMMER/EARLY FALL 6 LBS/1,000SF ANNUAL RYEGRASS  
LATE FALL/EARLY WINTER 6 LBS/1,000SF CEREAL RYE
5. CONTRACTOR SHALL MAINTAIN SEEDED AREA UNTIL A HEALTHY STAND OF GRASS IS ESTABLISHED WITH A GERMINATION RATE OF AT LEAST 85 PERCENT AND MINIMAL INERT MATERIAL.
6. APPLY STRAW MULCH-STRAW MULCH AS NECESSARY TO HOLD IN MOISTURE, PROTECT SOIL FROM EROSION, HOLD SEED IN PLACE, AND KEEP SOIL TEMPERATURES MORE CONSTANT. 3 BALES PER 1000 SQ. FT.

**STEEP SLOPE SEED MIX**  
DISTURBED SLOPES GREATER THAN 1:3 TO BE SEEDED WITH PREFERRED SEED'S "LOW-GRO MIX" OF HARD FESCUE, CHEWINGS FESCUE AND SHEEPS FESCUE OR AN APPROVED EQUAL AT A MINIMUM RATE OF 6 LBS PER 1000 SF AT COMPLETION OF SITE GRADING. SEEDED AREAS TO BE MAINTAINED THROUGH FULL ESTABLISHMENT OF GRASS, INCLUDING (3) MOWINGS.  
PREFERRED SEED CONTACT: 1-877-7333  
STABILIZE SLOPE WITH NORTH AMERICAN GREEN S150 EROSION CONTROL BLANKETS OR APPROVED EQUAL. INSTALL ACCORDING TO MANUFACTURER'S RECOMMENDATIONS, TYP.

**LAWN SEED MIX**  
Lawn areas to be seeded with Preferred Seed's "TRIO SUPREME MIX" or approved equal at a minimum rate of 5 lbs / 1000 SF. Seeding to be done at completion of site grading. Seeding areas to be maintained through full establishment of grass. Refer to lawn and meadow soil profile on detail sheet.

**DRIVE EDGE NATIVE SEED MIX**  
Native Right-of-Way Woods Mix with Annual Ryegrass (ERNMX-132-1) as supplied by Ernst Conservation Seeds (800) 873-3321, or approved equal. Based on site conditions after clearing, grubbing and earthwork, owners rep may require use of ERNMX-181 or similar. Consult owner's rep. prior to ordering seed.  
Application rate: 2 lb per 1000 S.F. min. use filler/ carrier material to spread.

25% Virginia Wildrye, PA Ecotyp  
20% Annual Ryegrass  
15% Fox Sedge, PA Ecotype  
11% Creeping Red Fescue  
10% Deertongue, 'Tioga'  
10% Switchgrass, 'Shawnee'  
5% Partridge Pea, PA Ecotype  
4% Autumn Bentgrass, PA Ecotype  
Total: 100%
