**WHEREAS**, the tentative budget is also posted on the Town's website, townofcanandaigua.org; and

WHEREAS, NOTICE IS HEREBY GIVEN that the preliminary budget of the Town of Canandaigua for the fiscal year 2017, including general Town funds, highway, special improvement districts funds, lighting district funds, and fire protection funds, will be filed by October \_\_\_\_, 2016, in the office of the Town Clerk of the Town of Canandaigua, 5440 Route 5 and 20 West, Canandaigua NY 14424, where it is available for inspection by any interested person during office hours; and
