Dear Mr. Oyler,

On behalf of the Ontario County Industrial Development Agency, McFarland Johnson is submitting a Preliminary/Final Site Plan Application to the Town Planning Board for the referenced Hangar project located within the Canandaigua Airport's 211.9-acre parcel, tax account number 70.00-1-74.110. The actual building site is located off an existing access drive off Brickyard Road near Runway 31.

The project site consists of construction of a +/- 6,000 square foot building (75' x 80') with a +/- 144 square foot bathroom/kitchenette (base bid), or a +/- 400 square foot office/bathroom/kitchenette (Add Alt #1). There will be water, electric, natural gas, and sanitary sewer utility connections to the building. The project is expected to be bid this winter for a spring 2021 construction start with a summer completion timeframe.

This project scope and objectives have been approved by the NYSDOT Aviation division and an AIR 2015 project grant for a total project cost of \$800,000 was awarded in January 2016. The project will continue to have oversight and approvals from NYSDOT prior to bidding and construction. The project "Sponsor" for the grant is the Ontario County IDA, the owners of the airport and they will also be reviewing the project throughout the design, bidding and construction process. The project's 100% Final Design Plans (including architectural and building plans) will be reviewed by the County Planning Department regarding issuance of a building permit.

The construction safety and phasing plans and details are provided in the plan set in accordance with FAA requirements which provides the contractor guidance on a sequence of construction. A 7460construction application will be completed and submitted to the FAA for the temporary and permanent work being performed for this project on the airport property.

- 7. NYSDOT Overall Project Design Approval: Prior to advertising for bids and prior to awarding the contract
- 8. NYSDOT Issuance of a Construction Grant
