Dear Shawna,

On behalf of our client, Josef's Artisan Meats, we are pleased to submit plans of the above referenced project for your consideration. We request that this project be placed on the agenda for the Planning Board meeting of July 12<sup>th</sup> for Sketch Plan Review as well as on the agenda for the Zoning Board of Appeals meeting of July 19<sup>th</sup> for Variance Approval.

The site is located on the northwest corner of Brickyard Road (a Town Road) and North Street (a City Street) and is zoned I – Industrial.

Artisan Meats is proposing to expand their operation at 2640 Brickyard Road to accommodate their growing business. A  $4,675 \pm sf$ , 2-story addition to the east and south of the existing building is proposed, as well as a  $6,950 \pm sf$ , 1-story addition at the southwest corner of the 2-story addition. 19 additional parking spaces will be constructed on the front (north) side of the addition and two truck access points from North Street will be added (1 entry only and 1 exit only). This project will not only provide additional production area, but also additional loading docks and improved vehicular circulation.

We have identified two variances that are required:
