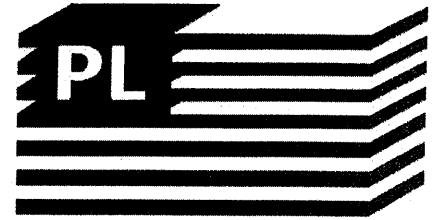

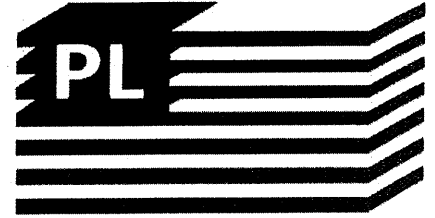
This contract between Peterman Lumber Inc. and: Bob Chevier
For a price identified below, Contractor agrees to complete for Owner the Work identified in this agreement as the project.

Project is as described and includes the following:

1. Install a 40' X 24' with a 10' wall pole barn garage on existing pad
 2. Install 1-3/0 fiberglass insulated Entry door with a Half-lite and 3-3'X4' Vinyl single hung Windows. Low-e w/ argon. Double strength glass
 3. Pressure Treated 6"x6" posts atop a 12"x14"x6" concrete block, minimum 42" deep per code
 4. 1 - CHI Model #3285 16' X 8' overhead door, insulated, no windows. With 15" standard track
 5. Engineered 16" LVL header above overhead door
 6. 1' Enclosed/ vented overhangs on all eaves and gables
 7. 40' Engineered Attic Truss 7/12 Pitch, 2' On Center 12'x24' attic space
 8. 2"x12" Hem Fir headers on back wall, 2"x4" roof purlins/ wall girts
 9. Classic Rib steel on Roof in the color of Forest Green
 10. Classic Rib steel on sidewall in the color of Earth Brown
 11. All necessary trim pieces and hardware for roof and siding (Earth Brown) to be included
 12. Concrete floor not included
 13. Includes all labor, insurances, and complete job cleanup
 14. Customer responsible for any permits
- Includes 40 year Film Integrity, 25 Year Chalk/Fade
