The finished floor elevation of the shed needs to be 2ft. above the SFHA (Special Flood Hazard Area) level of Canandaigua. Lake.

SFHA of Canandaigua Lake is 691.7ft. AMSL NGVD 1929

The pad that is down there.. definitely is not high enough.

You should address this elevation in your upcoming paver application as well. So you can slope the walkway to make the structure accessible.

You should have your surveyor/engineer provide your contractor with an fixed marker/elevation to work off of. (working off the correct datum – NGVD 1929)

At the end of the job.. we will need a stamped/sign elevation certificate detailing the floor elevation. Federal Law... FEMA
