

ECB Comments to the Town Board:

1. The task of reviewing applications by the ECB will be easier as a result of the compilation and updating of various maps and reports in the *Open Space, Conservation and Scenic Views Master Plan*.
2. The *Plan* provides an excellent outline for Town efforts to encourage landowners to implement conservation practices.
3. The *Plan* well identifies the ECB's potential partners for the implementation of the strategies.
4. The ECB encourages the Town Board to adopt the inventory of conservation resources as shown in the Plan's maps as the "Open Space Index" for the Town.

j. REFERRAL FROM THE PLANNING REVIEW COMMITTEE (PRC)

 Requesting Site Plan approval to combine two lots into one parcel and to construct a one-story frame addition to an existing single-family dwelling.

Mr. Cooper said that the applicants withdrew their original application for an addition to their single-family residence and the complete tear down and rebuild of the garage. They have resubmitted the application only for an addition to the existing residence.

Board members reviewed the winding path leading down the steep slope from the residence to the lakeshore and discussed the potential for erosion down the path.

Existing and proposed lot coverage and building coverage were reviewed on the Site Plan, as follows:

Existing Building Coverage:	4.5%	Proposed Building Coverage:	6.6%
Existing Lot Coverage:	23.1%	Proposed Lot Coverage:	24.9%

ECB Comments: The ECB recommends that the winding path leading down the steep slope to the lakeshore remain vegetative with the planting of White Dutch Clover on the path. The ECB recommends the closing of one driveway to reduce the percentage of lot coverage (the driveway opposite Foster Road is the safer of the two driveways). The ECB also recommends that the Planning Board require compliance by the applicants to the Shoreline Development Guidelines.

k. OLD BUSINESS

1. ECB Page for Town Newsletter, August 2018:

Ms. Davey has prepared the ECB page in the August issue of the Town Newsletter on the topic of bird habitat.

Ms. Marthaller said that Kaitlynn McCumiskey of the Highway Department will assume a greater role in the public-information initiatives for the Food Recycling and Composting programs. She said that the ECB will still have responsibilities for portions of these programs but that Ms. McCumiskey and the Town Environmental Committee will assume greater roles as the ECB transitions to efforts related to the implementation of the *Open Space, Conservation and Scenic Views Master Plan*.

For future newsletter pages, Ms. Marthaller said that the ECB may wish to reprint articles from various sources on pertinent environmental issues which affect the Town.

2. Food Waste Recycling:

Ms. Marthaller said that monthly reports are expected on how many pounds of food waste are recycled at the Transfer Station and picked up by the vendor. The reports are also expected to include the number of residents who participate in this program. Mr. Bloom suggested that increased promotion and marketing of the program is needed to raise participation rates.
