### **PROJECT DESCRIPTION:**

- Request for a Certificate of Preexisting Non-Conformity for a previous dealership and auto repair facility that no longer has the dealership attached.

## **DETERMINATION:**

- The survey for lands at 2555 State Route 332 indicates that the building on the lot was originally used for auto shop and sales, indicating both dealership and auto repair/service both existed at the time of the survey. In the 1977 Town Code automobile service station and auto mobile sales were both permitted uses in the C-1 zoning district. These uses required no special use permits and could both occur on the same property alone or simultaneously. The information in the current file for the property at 2555 State Route 332 has no information regarding a stop in uses since the dated survey. Therefore, under Chapter 220 §220-107 A., the use of the property at 2555 State Route 332 as an motor vehicle repair station is a preexisting non-conforming use and requires no special use.
