Requesting an Area Variance (Zoning Board of Appeals) and a Single-Stage Site Plan approval (Planning Board) for construction of a new single-family dwelling

Review was based on:

- Application materials on file as of 7-5-18
- Property photos on file with Town Assessor
- Ontario County On-Cor maps
- Town policies and environmental feature maps incorporated in Comprehensive Plan and Land Use Planning documents adopted by Town Board – see attached check list

Findings, based on review of maps in draft Open Space Plan:

- 1. Conservation value rating for the parcel is 2 out of 5 (low)
- 2. Ecological Community for the parcel is partly Northern Hardwood Forest, partly Successional Old Fields, but aerial photo in OnCor shows limited forest areas.
- 3. There is a Class C stream and gully on the property. The home maintains a setback of 150' plus from the rim of the gully.
- 4. The parcel has some steep slopes, but the plan locates the building and site plan away from the slopes, with the exception of the pipe linking the home to the septic field, which goes through a steep and wooded zone.
- 5. Parcel is within the Strategic Forest Protection Area, but the home and septic field are sited in relatively open areas.
- 6. Agricultural soil suitability is Prime Farmland if Drained/Farmland of Statewide Importance.

- 7. Site has views of Canandaigua Lake and portions can be seen from Canandaigua Lake (distantly).
- 8. Nearest PDR is Hick Farm (one mile plus)

Motion:

■ A motion was made by MR. DAMANN, seconded by MS. DAVEY, that the Environmental Conservation Board recommends that this application move forward with comments.

Comments:

- 1. ECB anticipates no adverse environmental conservation impacts.
- 2. Septic field siting requires crossing a steep slope area for connecting pipe. ECB notes need to minimize disturbance in this area.
