
he Town of Canandaigua continues to be a leader in the State of New York relating to farmland protection and the promotion of Agriculture. Our Town of Canandaigua Agriculture Advisory Committee continues to work to explore new avenues for the promotion of Agriculture as an industry, while also fostering new interest in agriculture through public awareness and education including exploring new opportunities to teach children about the importance of agriculture. The Agriculture Committee continues to implement the goals of the Town's Agriculture Enhancement Plan and continues to pursue opportunities for the protection of

farmland through programs like the Purchase of Development Rights (PDR), Transfer of Development Rights (TDR), Open Space Protection, the Town's Strategic Farmland Protection Area, and the Town's Padelford Brook Greenway.

The Town of Canandaigua is very fortunate to once again be the recipient of PDR awards from the New York State Department of Agriculture and Markets. In each PDR round since 2014, the Town of Canandaigua has received grant awards for protection of Farmland by partnering with the Finger Lakes Land Trust. In late December 2018, Governor Cuomo announced a record \$35 million in farmland protection grants, with the Finger Lakes getting the largest amount of \$10.1 million for eight different projects, totaling 4,089 acres. Two of the eight projects are located in the Town of Canandaigua resulting in the protection of a 601 acre farm (Kim-Mar

Farms, LLC) and a 187 acre farm (Pendleton Farms – Purdy).

The Town of Canandaigua received its first ever direct PDR award for Pendleton Farms in this most recent round and is one of only three municipalities in the entire State of New York (as opposed to a Land

Trust) to receive to receive this award.
This demonstrates the NYS Department of Agriculture and Markets' acknowledgement of the Town of Canandaigua's strong commitment to agriculture protection.

Previous PDR awards for Farmland Protection in the Town of Canandaigua include Brock Acres Farm (2016), Catalpa Acres (2014), Hicks Farm (2009), and Wyffels Farm (2008); all are shown in the above map. These most recent announcements will bring the total protected farmland in the Town of Canandaigua to more than 2,000 acres free from future development potential, and ensure that agriculture continues to be viable in the Town for generations to come.

Taking a CLOSER LOOK

At the OPEN SPACE, CONSERVATION &

SCENIC VIEWS MASTER PLAN

n the coming year the Environmental Conservation Board (ECB) begins an exploration of the new Open Space Master Plan. For more than a year, a dedicated Committee of residents undertook the task of updating the previous 2006 Plan. In the late summer of 2018, after participation of residents in many public meetings and an online survey, the Town Board adopted a revised Plan. The

Master Plan can be viewed **here**.

As residents we do enjoy a wonderful quality of life. We value the beauty of Canandaigua Lake and the rural nature of our Town. The Plan articulates this vision and provides tools to achieve it.

"Preserve the Town's open spaces for their health, economic, social and environmental

benefits and to maintain a high quality of life for residents of the Town of Canandaigua."

".....the Plan documents the Town's open spaces and identifies those with the highest potential impact as

conservation lands. It describes tools that the Town can use to protect its open space resources. Finally, it presents a detailed implementation strategy and actions steps to ensure the protection of the Town's high priority open spaces and its rural character."

This year the ECB will actively begin to engage in these Strategies and Implementation Action Steps that have been assigned to us in the Plan. And we will discuss these Action Steps in upcoming newsletter articles and relate our progress in 2019. We have chosen five ambitious goals for this year:



stewardship by

landowners. Schedule a forum for landowners to encourage the benefits of the value of trees as a hydrologic feature; develop a land stewardship training for residents; provide information on sources of technical assistance and financial incentives for conserving land.

Enhance wildlife habitat.

Reach out to the Ontario County Soil and Water
Conservation District for a possible tree giveaway program;
schedule a forum to encourage landowners to plant native
species; provide forest management, effective habitat
management and technical assistance information; manage
Town-owned land to enhance wildlife habitat.

Conserve open space through land use regulations. Review stream corridor, lakeshore, and other regulations pertaining to open space protection; develop recommendations for the Ordinance Committee.

Acquire land and/or conservation easements for land with exceptional conservation value. Partner with Finger Lakes Land Trust to develop a list of top priority parcels of conservation value; plan a public workshop for landowner participation in a Conservation Easement Program; provide information on sources of technical assistance and financial incentives for conserving land.

Increase understanding among government officials and the general public about the benefits of open space. Conduct periodic workshops and other educational events and programs to celebrate the Town's open space; plan a Bird Habitat presentation at Miller Park in the spring; prepare newsletter articles on open space topics

throughout the year.

The ECB looks forward to serving our community in its open space initiatives. Please join us in learning more about natural resource protection and preservation in the coming months.

News You Can Use from the Assessor's Office

here have been additional changes to the STAR program this year. New for 2019, if you're applying or reapplying for the Enhanced STAR exemption, you must enroll in the Income Verification

Program (IVP). You only need to enroll



once, and you'll receive the exemption each year, as long as you're eligible.

Additional benefits include:

- The comfort of knowing you can't miss the renewal deadline—because it doesn't apply to you, and
- Privacy—you'll no longer need to share your income tax returns with the assessor's office.

In the first year, the assessor will verify your eligibility based on the income information you provide. In the following years, the State will verify your income eligibility. You will not need to reapply for the exemption or provide copies of your tax returns to your local assessor.

If you have enrolled in the Senior Program, you will be required to fill out the IVP form this year only. Going forward, the renewal process for the Senior Exemption will be every year, as it has been in the past. All these forms are due in the Assessor's office by March 1st 2019, so if we do not hear from you by early February, you can expect a reminder call.

2019 Tax Bills

he 2019 Town/County tax bills were mailed on December 31, 2018. If you did not receive your tax bill or would like another copy, property owners can CLICK HERE and print a copy. You can also contact the Town Clerk's office and a copy can be emailed to you.

Here are some tips to help you pay your tax bill:

- Tax payments will be accepted until close of business on Monday, April 1, 2019. To avoid a late fee, payments should be made by January 31, 2019.
- Your tax payment must be made for the exact amount written on your bill. Any checks written for the wrong amount or not signed will be returned.
- If you are using an online banking service to pay your tax bill(s), please read your agreement, as the bank may not mail your payment to

the Town for up to seven days after withdrawing the money from your account, which could cause your tax payment to arrive after January 31st, thus incurring a late fee.

- For payments made by mail, the
 United States Postal Service
 postmark (not a postage meter
 mark) is used as the payment date
 (RPTL §925). If there is no
 postmark, the date the payment is
 received will be used as the
 payment date. You will need to
 make sure your envelope is
 postmarked January 31 or before
 to avoid paying the penalty fee.
- You may pay your tax bill online
 HERE using a credit or debit card. If
 using this method of payment,
 there will be a processing fee of
 \$3.95—or 2.45%—for the
 transaction (i.e. if your tax bill is
 \$159 or less, the convenience fee
 will be \$3.95. If your tax bill is \$160
 or greater, the convenience fee will
 be 2.45% of the amount paid).
- From January 1 through January 31, 2019, property owners, when

- paying their tax bill in full, can pay their 2019 County / Town tax bill at any Canandaigua National Bank office.
- Property owners have the option to pay their 2019 County / Town tax bill in two installments. The first installment must be paid by Thursday, January 31, 2019. The second installment can be paid during the month of February with a 1% penalty or during the month of March with a 2% penalty. The installment payments can be made online with a credit/debit card, mailed with a check payable to the Canandaigua Tax Receiver, or in person at the Town Clerk's office.
- The Town Clerk / Receiver of Taxes office is open Monday through Friday 8:00 am to 4:00 pm and every Wednesday until 7:00 pm (except legal holidays).

Winter Weather Safety



The Town of Canandaigua Highway Department would like to thank all Town residents for following these safety tips during the winter. Your cooperation improves our efficiency and safety, and is very much appreciated.

- 1. There is a no parking ban on all roads in the Town of Canandaigua from November 1st to April 1st. Please keep parked cars off the roads. If a vehicle impedes traffic or obstructs our snow plowing operations it will be towed at the owner's expense.
- 2. Please refrain from plowing snow from private property onto or across public roads. This presents a hazard to drivers and is, in fact, illegal. It is also best to plow snow to the right side of your driveway (if looking toward the road) in order to avoid having the plow push snow that has been cleared back into your driveway.
- 3. Please keep a safe distance behind Town trucks, plows, or any large vehicles. Trucks frequently back up at intersections; please give them extra space.
- 4. Never let children play in snow drifts or banks near the road. This is very dangerous as it is very difficult for plow operators to see them.
- 5. Keep your house numbers clear and visible in case of emergency. If you have a fire hydrant on or near your property, consider shoveling out around it.

TOWN OF CANANDAIGUA SEEKS RESIDENTS INTERESTED IN SERVING ON SEVERAL TOWN COMMITTEES

(Canandaigua, NY) – The Town of Canandaigua is seeking community members interested in volunteering on any of several Town committees or project teams for which upcoming vacancies are expected. Are you passionate about protecting the Lake and our open spaces or have an interest in environmental sustainability? Are you interested in farming or agriculture? Does local history spark your interest? Are you interested in improving the Town's parks and recreation programs or do you like event planning and community organizing? Do you have another skill or experience you think could benefit the Town and the greater Canandaigua Community? We are also interested in youth members – do you know a high school student whose interests fall into any of these categories? If you can say "Yes" to any of these questions, then the following Town Committees would like to hear from you:

Agricultural Advisory Committee

This committee has worked towards furthering the protection and promotion of agriculture in the Town and greater Canandaigua community for over two years. Supporting farming families, promotion of agribusiness, participation in the County Fair and other Ag events, and agricultural education in the schools are all topics covered at Committee meetings. They meet once monthly on Thursday evenings.

Citizens' Implementation Committee

The CIC is a dedicated group of former board members and residents that started in 2014 with the goal to fully implement the 20 goals identified in the Town of Canandaigua's Comprehensive Plan. For the past four years, the CIC has prioritized goals each year and in 2019 they will be preparing an update to the Comprehensive Plan; this will include developing revised goals and new action steps. This Committee meets twice monthly on Tuesday mornings at 9:00am.

Environmental Committee

This Committee has been focusing its efforts on public outreach and education relating to waste reduction and increasing resident participation in recycling. The goal is to help our community become more sustainable and to prepare for the closing of the Ontario County landfill in 2028. If you share a passion for sustainability and recycling and want to help get the word out, please consider joining this group. Currently, the Environmental Committee meets once a month on Wednesday afternoons.

Local History Team

This group began in early 2018 and has been very active in protecting and promoting local history. Projects have included applying for (and receiving) a grant to research the history of the town including an inventory of all buildings over 50 years old; they created a page on the Town's website featuring historic maps of the town; and the most recent project has been the education of visitors to the Town hall on the historic Canandaigua Lake steamboats – each conference room is named for a different ship. If you're a fellow history buff or want to learn more, let us know and join the team. They meet once a month on Thursday mornings.

Parks, Trails & Recreation Committee

If you love your parks and want to help with planning new recreation programs, including both youth and adult programs, ideas for park or trail improvements, and to help the Town plan for the future of our town parks, then consider attending or becoming a member of this committee. They meet once monthly in the evenings; with meeting locations rotating between the various parks.

Special Events Committee

The Special Events Committee is looking for creative, dedicated individuals interested in events and party planning. In the past three years they have built floats for the 4th of July Parade, winning a trophy each year; exhibited at the Ontario County Fair and at the Historical Society; planned and held the first Town Open House at the new Highway Facility; and have become famous for the annual Halloween @ Onanda Park, attended by hundreds of families, rain or shine. They would love for you to join them. The Events Committee meets as needed; sometimes meeting more than once a month in the time leading up to an event.

All of these opportunities are volunteer positions. Members of these groups meet regularly, most of them monthly, to work towards goals set early in the year.
