ATTACHMENT "A"

SECTION ONE. Canandaigua Town Code § 152-6(HH) shall be replaced in its entirety with the following: "No entry is permitted into West Lake Road Schoolhouse Park from the waters of Canandaigua Lake."

SECTION TWO. The following new subsection shall be added at the end of Canandaigua Town Code § 152-6:

QQ. No entry is permitted into Onanda Park from the waters of Canandaigua Lake, unless receipt of a proper payment is presented to Town Park Staff upon request, per the Town Board's adopted fee schedule. Only nonmotorized canoes, kayaks, paddle boards, recreational sculling or similar nonmotorized vessels may be permitted.

SECTION THREE. Canandaigua Town Code § 153-2(A)(6) shall be replaced in its entirety with the following: "A written statement listing the specific dates when the applicant intends to solicit orders;"

SECTION FOUR. Severability. If any portion of this Local Law shall be deemed by a court of competent jurisdiction to be invalid, illegal, or unenforceable, the remainder of this Local Law shall remain in full force and effect.

SECTION FIVE. Effective Date. This Local Law shall be effective immediately upon its filing with the New York State Secretary of State.
