Schedule "A"

SECTION ONE. Town Code §202-15(B) shall be replaced in its entirety with the following:

B. When an inspection is required by Article III of this chapter, the authority having jurisdiction shall order the parcel owner to provide a report of findings attested to by a design professional or an on-site training network certified inspector as will adequately describe the type, capacity, location of the elements of the existing system, condition, and functionality of the existing system in order to determine that all of the requirements of this chapter have been complied with. Upon receipt of order, the parcel owner shall be given 30 days to complete a new inspection of the on-site wastewater system and submit a report of findings to the authority having jurisdiction. If refused, the authority having jurisdiction shall apply to a court of competent jurisdiction for a search warrant.

SECTION TWO. Town Code § 202-15(C) shall be replaced in its entirety with the following:

C. The authority having jurisdiction, upon show of due cause, shall order the parcel owner to provide a report of findings attested to by a design professional or an on-site training network certified inspector as will adequately describe the type, capacity, location of the elements of the existing system, condition, and functionality of the existing system. Upon receipt of order, the parcel owner shall be given 30 days to complete a new inspection of the on-site wastewater system and submit a report of findings to the authority having jurisdiction. If refused, the authority having jurisdiction shall apply to a court of competent jurisdiction for a search warrant.

SECTION THREE. Severability. If any portion of this Local Law shall be deemed by a court of competent jurisdiction to be invalid, illegal, or unenforceable, the remainder of this Local Law shall remain in full force and effect to the extent practicable.

SECTION FOUR. Effective Date. This Local Law shall be effective immediately upon its filing with the New York State Secretary of State.
