PLEASE NOTE that the number of hours will be SIGNIFICANTLY INCREASED due to incomplete applications, plans lacking detail, or repeated continuations. Subdivision applications and larger commercial or industrial projects traditionally require more hours of engineering, legal, and other consultant review and preparation and will incur higher costs. Applications for new construction may be referred to the Town Engineer for engineering review which may include at least an additional eight to twelve hours of review time. The **Property Owner** will also be responsible for legal fees for applications submitted to the Town of Canandaigua Planning Board, Zoning Board of Appeals, or the Town of Canandaigua Development Office. Fees for engineering and legal expenses traditionally range between one hundred and one hundred fifty dollars per hour. A copy of the Town's annual fee schedule is available upon request from the Development Office or the Town Clerk's Office. The **Property Owner's** signature below indicates that the **Property Owner** understands that the **Property Owner** will be responsible for all outside consultant fees incurred as a result of the submitted application, and consents to these charges. ### Chapter 174 §174-9

### Must Be Shown On Survey Plat

A. Sketch plans shall be clearly marked as such and shall identify:

(1) Existing general land features;

(2) Existing and proposed development including buildings and pavement

(3) Existing and proposed lots with lot dimensions and areas;

(4) Proposed land use(s) and zoning;

(5) Utilities;

(6) Location and nature of all existing easements, deed restrictions and other encumbrances;

(7) Environmentally sensitive features identified on the NRI.

B. It is the responsibility of the applicant to provide a sketch plan that depicts a reasoned and viable proposal for subdivision and subsequent development of the lot(s).

C. Planning Board members may suggest modifications to, but shall not approve or disapprove the sketch plan. Comments made by individual Board members during sketch plan review shall not be interpreted as constituting approval or disapproval by the Board, nor shall they be interpreted to limit the scope of any subsequent review or approval of a derivative plan.

Other Requirements:

1. Date, north point, and scale. The plan shall be at a scale of no more than one hundred (100) feet to the inch.

2. Name and address of the owner of the property.

3. Name of engineer, surveyor, or architect responsible for the plan.
