You are hereby notified that you have been found to be in violation of the Town Code Chapter 92. The specific violation is:

- Failure to install turnaround in conformance with approved plans and Section D103 of Appendix D of 2020 Fire Code of New York State.

as observed by the Zoning/Code Enforcement Officer on January 13, 2022.

2020 Fire Code of New York State - Appendix D

D103.4 Dead ends. Dead-end fire apparatus access roads in excess of 150 feet (45 720 mm) shall be provided with width and turnaround provisions in accordance with Table D103.4.

FIRE APPARATUS ACCESS ROAD. A road that provides fire apparatus access from a fire station to a facility, building or portion thereof. This is a general term inclusive of all other terms such as fire lane, public street, private street, parking lot lane and access roadway.

The following corrective measures should be taken no later than February 14, 2022, or penalties may be assessed:

Installation of Fire Apparatus Turnaround per approved plans.

PLEASE NOTE: In addition to those penalties prescribed by state law, any person who violates any provision of the Uniform Code, the Energy Code, the Town Code, or any term or condition of any building permit, certificate of occupancy/certificate of compliance, temporary certificate, stop-work order, operating permit or other notice or order issued by the CEO pursuant to any provision of this chapter shall be liable for a civil penalty of not more than \$250 for each day or part thereof during which such violation exists or continues. The civil penalties provided by this section shall be recoverable in an action instituted in the name of the Town of Canandaigua.
