Connor,

Anthony did call me yesterday after I sent that email. At the risk of repeating what he may have already told you, I'll try to clarify below.

In my determination of how the project complies with zoning, I noted that the project would require a use variance for two dwellings on the parcel. The issue largely relates to the pool house.

In this zoning district, One Singe Family Dwelling or One Single-Family Dwelling with accessory apartment are allowable uses. Essentially a dwelling or dwelling unit is a habitable building with facilities for sanitation, sleeping, cooking, living, and intended to be used for living facilities for a person. And because the 2nd proposed dwelling unit (pool building) is not contained within the principle dwelling it cannot be considered an accessory apartment.

So, since what is proposed is not an allowable use, it would require a Use Variance to proceed. Use Variances place a high burden on applicants. There are a number of elements to be provided and *each* must fall in your favor. A little information here: https://www.dos.ny.gov/lg/publications/Zoning Board of Appeals.pdf

What the Town needs to proceed is the application and materials for a Use Variance, or a change to the proposed development to eliminate the need for such a variance.
