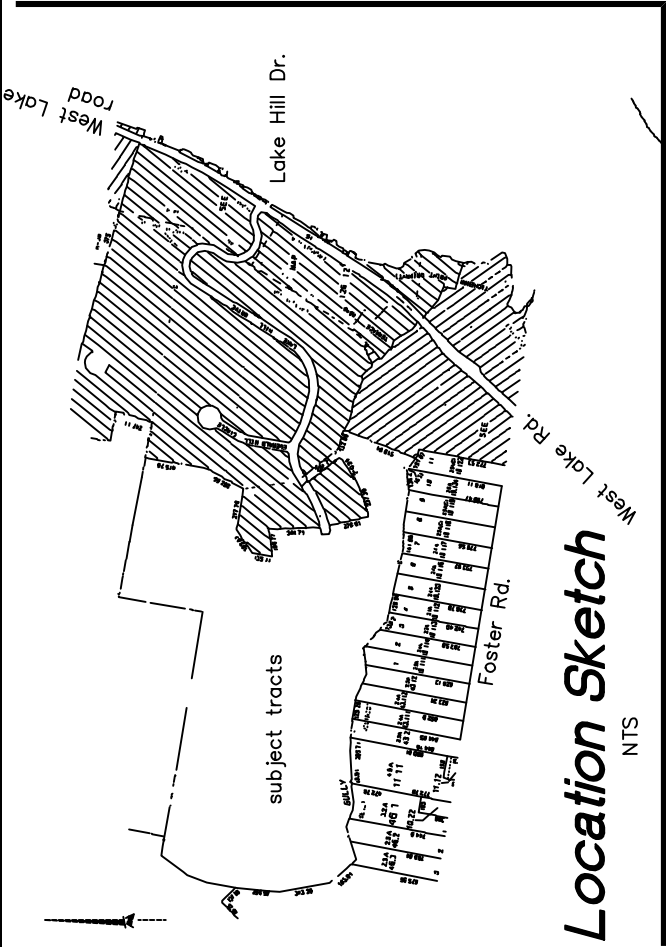


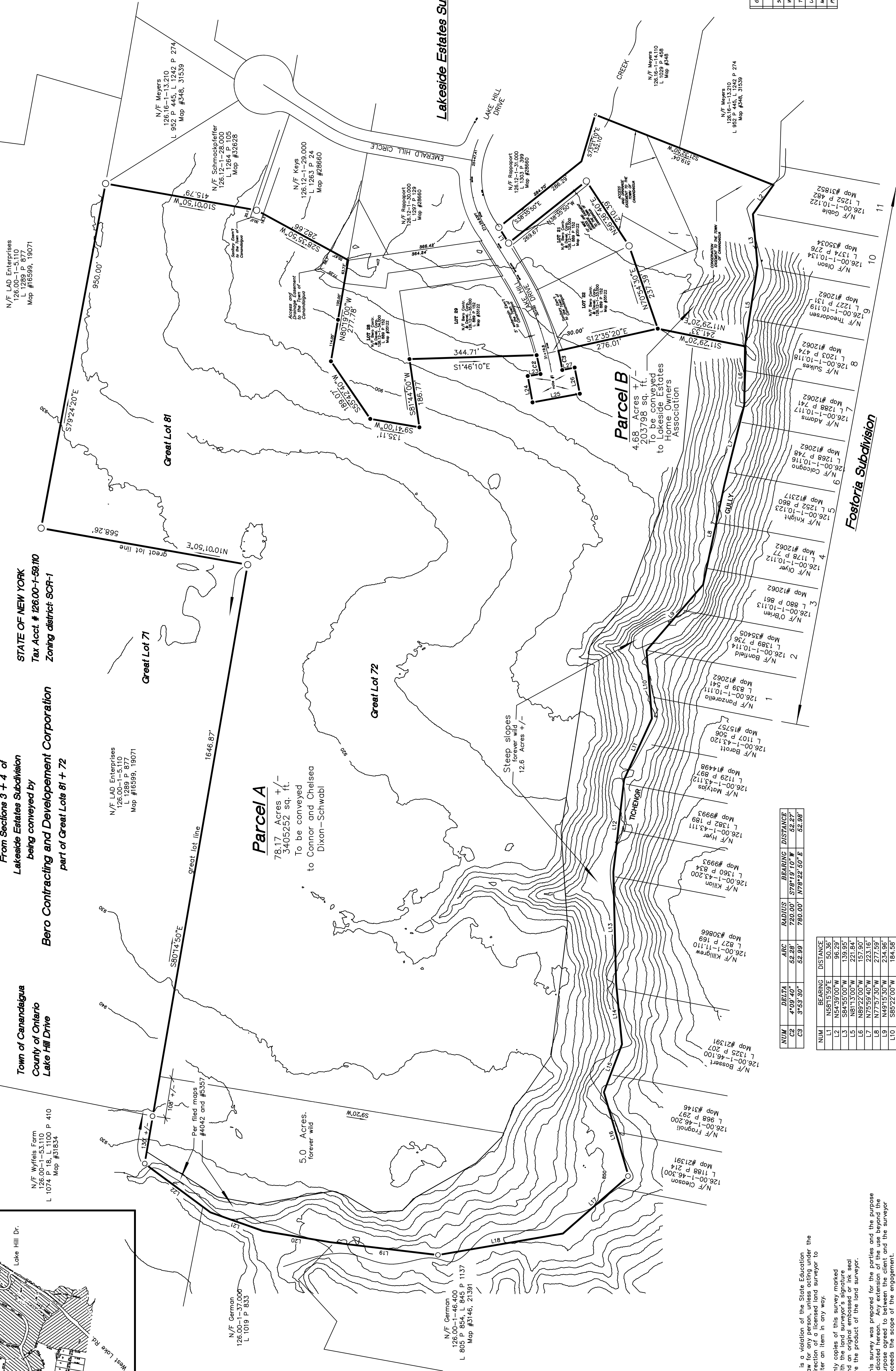


Location Sketch
