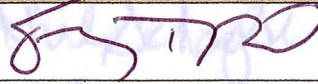
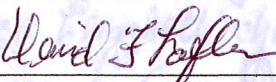
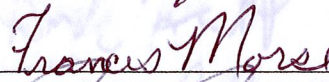
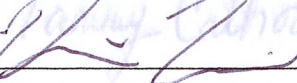
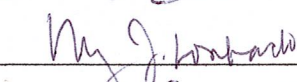
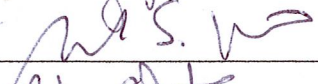


Petition to Stop Future Site of North Road and Andrews Road Solar Farm
