Thank you for your time earlier and allowing me to bend your ear. Attached is a photo of the card Bruce Kersch was handing out to guests at a bbq we had at our house earlier. This is an advertisement for the Halloween house tour we have been discussing. Last year They had 850 - 1,000 Halloween Open House visitors over the course of three different nights. He has expressed to me on a few occasions over the past 8 months that he intends to triple that this year, so as many as 3,000 people, which brings a countless number of vehicles.

Also attached are photos of signs he put in his yard after I asked him to reconsider the house tour without the consent of his local neighbors. These signs were up for the 10 days leading up to and including our annual bbq, which he was invited to and attended. Later the next week the signs were removed, likely due to the receipt of the registered letter from the town. We have not had any interaction since this point and all interactions thus far have been neighborly.

These signs are an indicator that my goal of maintaining our friendly and at times jovial rapport, may not be achievable. Although my goal is still in place, at this point we have made a conscious decision to avoid engaging in any dialect with them at all.

Keep me posted as we discussed as I could, if necessary, be able to provide a list of the names and contact information of Old Brookside neighbors that are vehemently opposed to this open house and the issues it brings to our once quiet and tactful neighborhood.

Lastly, also included is a photo of what his house looks like at night and this is representative of what his front and back yards look like every night of the year. It gets more intense during Halloween, Christmas, Valentines Day, St. Patrick's day & Easter.
