

RESOLUTION NO.2023 - 191: HIRING CODE ENFORCEMENT OFFICER FRANCHESKA MUNIZ

WHEREAS, the Town of Canandaigua recognizes the need for effective code enforcement to ensure the safety, health, and well-being of its residents; and

WHEREAS, the position of Code Enforcement Officer plays a vital role in enforcing local codes and ordinances, promoting compliance, and maintaining the quality of life in our community; and

WHEREAS, the Town has conducted a thorough recruitment and selection process for the position of Code Enforcement Officer, resulting in the identification of a highly qualified candidate, Francheska Muniz; and

WHEREAS, the Town Manager, Human Resources & Payroll Coordinator, and Code Enforcement Officer recommend the hiring of Francheska Muniz; and

WHEREAS, Francheska Muniz has demonstrated the necessary skills, knowledge, and experience to effectively carry out the responsibilities of the Code Enforcement Officer; and

WHEREAS, it is in the best interest of the Town to secure the services of Francheska Muniz as the Code Enforcement Officer.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Canandaigua the Town Manager is authorized to execute all documents relating to the hiring of Francheska Muniz at a rate of \$57,5000; and

BE IT FINALLY RESOLVED, the Town Clerk is directed to provide a copy of this resolution to the Town Manager, HR & Payroll Coordinator, and Francheska Muniz.

RESOLUTION NO.2023 – 192: RESOLUTION REQUESTING AN EQUITABLE TAX RATE ASSESSMENT BY ONTARIO COUNTY

WHEREAS, the Town of Canandaigua recognizes the importance of equitable tax assessments and fair taxation practices; and

WHEREAS, it has come to the attention of the Town Board of the Town of Canandaigua not all municipalities in Ontario County are currently assessed at 100% valuation; and

WHEREAS, certain residents of municipalities who have completed a revaluation as of the July 1, 2023 final tax roll with 100% valuation will be subject to substantially higher real property tax dollars than in previous years, resulting in additional tax revenue for Ontario County; and

WHEREAS, it is imperative that Ontario County ensures fairness and consistency in tax assessments and seeks to mitigate the potential burden on residents as a result of increased tax rates; and

WHEREAS, if Ontario County were to hold the line on the tax levy consistent with cost of living adjustments, it would be appropriate to reduce the base tax rate from the 2023 budgeted tax rate of \$6.31 per thousand dollars of assessed value to a lower rate for the year 2024; and

WHEREAS, in 2023, residents of the Town of Canandaigua paid \$7.33 per thousand dollars of assessed value for Ontario County taxes, resulting in a total contribution of \$10,367,455 in real property taxes to Ontario County based on a taxable value of \$1,414,386,748; and

WHEREAS, for 2024, if Ontario County intends to collect the same amount of \$10,367,455 from Town of Canandaigua residents along with a 3% cost of living increase, the amount needed to be collected should be adjusted to \$10,678,478; and

WHEREAS, considering the Town of Canandaigua's taxable value as of July 1, 2023, which stands at \$1,930,935,285, it is reasonable to lower the Ontario County tax rate for residents of the Town of Canandaigua to \$5.53 in order to generate the same amount of tax revenue for Ontario County, including a 3% increase for cost of living adjustments.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Canandaigua:

1. That the Town Board of the Town of Canandaigua formally requests Ontario County to assess the 2024 tax rate equitably, taking into account the variations in valuation among municipalities.
2. That Ontario County is urged to consider the potential impact of increased tax rates on residents who have completed a revaluation with 100% valuation, and to adopt measures that mitigate any undue financial burden on these residents.
3. That Ontario County is requested to hold the line on the tax levy consistent with cost of living adjustments, leading to a reduction in the base tax rate for the year 2024.
4. That the Ontario County tax rate for the Town of Canandaigua should be lowered to \$5.53 per thousand dollars of assessed value to ensure that the same amount of tax revenue is generated from Town of Canandaigua residents, including a 3% increase for cost of living adjustments.

BE IT FURTHER RESOLVED, the Town Clerk of the Town of Canandaigua is directed to provide a copy of this resolution to Town of Canandaigua Supervisor Jared Simpson, all members of the Ontario County Board of Supervisors, Ontario County Administrator Christopher DeBolt, Town of Canandaigua Town Manager Doug Finch; and

BE IT FINALLY RESOLVED, the Town Clerk of the Town of Canandaigua is directed to post a certified copy of this resolution on the Town of Canandaigua's website, and social media platforms to share this information with the residents of the Town of Canandaigua.
