## Hi Kaitlynn,

Summer flew by!! But I love the fall so I am looking forward to the next couple of months.

- 1. We ask residents to fill out an application and provide proof of residency (license, utility bill, tax bill etc) and registration(s) to vehicles (we allow 2 permits/household). Then we issue a permit that looks like the attached with their name, address, vehicle information (printed on different color Safety paper each year).
- 2. When we had stickers with just a number on them we had many issues with people from other town's coming with their vehicles. Putting vehicle information and name on permit has eliminated this problem.
- 3. We only have 1 full time transfer station employee that also helps the highway in the winter. He does all the hauling and works in the Transfer Station. The rest of the staff is part-time and they work different days but there is a total of 4 we pool from.
  - a. 2 work during the weekdays (Monday, Wednesday, Friday) along with our full time employee.
  - b. 2 work Wednesday evenings
  - c. 4 work on Saturdays
- 4. I believe our permit fees are going up next year, but currently we charge:
  - a. Residential \$125/year (based on date of purchase)
  - b. Senior permits (65 and over) \$110 (based on date of purchase)
  - c. Commerical permits \$125 (based on date of purchase) Recycle materials ONLY
  - d. Punch card \$100 (5 punches and only 1/year). This does not expire until all punches are used up.

Hope this information helps. Let me know if you need anything else. I've done a lot of research around the County too. A lot of different scenarios out there.
