The applicant shall submit the following requested information to the Town Development Office prior to 4:00 p.m. FRIDAY, JUNE 19, 2020, to be considered for the TUESDAY, JULY 28, 2020, Planning Board agenda.

1. See attached *One-Stage (Preliminary & Final) Site Plan Checklist*—All items with an open circle to the right must be addressed prior to the application being further processed, as follows:

General Content:

All dimensions shall be shown in feet and in hundredths of a foot.

Names of owners of all abutting land: South property owner.

Name and seal of the New York State licensed professional engineer or surveyor responsible for the plan.

A signature block for the Planning Board Chairperson and others as may be required.

Current zoning of the land including district boundaries and all setback dimensions for said zoning district(s): *Incorrect. RR-3*.

Existing Conditions:

All existing property lines, with bearings and distances including the subject (parent) Tax Map numbers.

Required building setback lines on each lot.

Sufficient data to determine readily the location, bearing and length of every existing street, easement, lot and boundary line and to reproduce such lines on the ground.

Proposed Conditions: Development:

Delineation of limits of any land to be disturbed in any manner including areas to be cleared of vegetation, cut, filled, excavated or graded. The delineation shall include dimensions and other references needed to allow efficient field verification: (?) disturbance limits.

Location and widths of all proposed driveway intersections with streets and sight distances therefrom. Suitable means of access in accordance with Town Code and Town of Canandaigua Site Design and Development Criteria.

Location of all other proposed utility lines and related facilities including gas, electric and telephone.

Final Site Plan Requirements—Chapter 220, Section 220-70:

Cost estimates for improvements where surety may be required by the Planning Board including but not limited to: landscaping, and stormwater and erosion control measures. Sureties shall comply with Town Code § 174-32 "Surety."

- 2. Clarify the areas of disturbance.
- 3. Submit a New Structure Permit application.
- 4. The applicant shall provide 2 complete hard copies of the plans. The applicant shall also submit a **PDF FILE** of the plans via e-mail to the Development Office at:

Information for the Applicant:

- 1. The applicant will receive a copy of the Planning Board meeting agenda approximately 10 days prior to the meeting date. The applicant is required to be in attendance at the meeting. If the applicant cannot attend the meetings and wishes the Planning Board to act on the application in their absence, the applicant shall contact the Development Office prior to 12:00 p.m. the day of the meeting.
- 2. The property owner is on notice that no development shall commence until the proper permits have been obtained from the Town's Development Office.
- 3. Your application will be referred to an outside consultant and/or consultants hired by the Town of Canandaigua (Town Engineer, Watershed Inspector, Town Attorney, etc.). *YOU—the property owner—will be invoiced by the Town for the reimbursement of these expenses.* The property owner is on notice that he or she is responsible for reimbursing the Town for any/all consultant fees accrued by the Town regarding this application. This includes resolutions written by the Town Engineer for each Zoning Board of Appeals or Planning Board meeting.
