Hi Michelle,

Thanks for sending these out to me. Let's look at each one.

CPN 20-080: This location is west of Route 332, entering on Thomas Road. When the Route 332 project to expand from 2 lanes to 4 lanes occurred, the NYSDOT bought several strips of land along side roads. The thinking was that the NYSDOT could control what goes on at the corners of these intersections. When this first came up, ironically at the SW corner of the Thomas Road intersection, we treated this as a Town permit, with a copy to the NYSDOT, understanding that we would like to review what was going in, and not allow anything permanent in that strip of NYSDOT R.O.W. There is an entrance that that currently exists. This new entrance is slightly larger, but essentially, this is the closest to the intersection where we would want an entrance for that parcel. Therefore, we concur with the location of the proposed entrance.

CPN 20-081: Several years ago, a water detention pond was built on this property. It shows up on the revised sketch plan. There was a temporary driveway installed so equipment could build this pond. That driveway was never removed, as per permit. Now, another driveway is proposed to go about 200' east of that driveway. Both are shown for the same parcel. This would be the time to have a shared access and utilize that existing driveway only and not construct a new driveway. Solar farms, once built, are accessed periodically for maintenance. This would be similar to that detention pond entrance. The NYSDOT does not support adding a second entrance for the construction of a solar farm.
