Glenn was able to turn around the request very quickly. A couple of points about the depiction:

- The roof slope shown in this depiction is front-back. It will be left-right. Showing it in this fashion helps the reader to see how little of the main wall will be visible.
- The picture shows that the lower 10'-12' of the building will not be visible from the road. Personnel doors, windows, and landscaping at the front of the building will not be visible. The tops of the overhead doors will be visible.
- The picture shows that shrubs near the highway right-of-way line will not be visible.
- Also, please recall that the building is approximately 345 feet from the southbound lanes.
