Hi Greg- Thank you for reaching out so quickly. Same parcel, very different proposal. The original road, with the townhome project, extended from 364 through the parcel to the Hopewell side. It was never decided if the two roads would ultimately link before the project was denied. This new proposal does have access on 364 but it will only be for 19 single family lots and there is no connection east, to the other side of the development.
