ATTACHMENT "A"

Be it enacted by the Town Board of the Town of Canandaigua as follows:

SECTION ONE. Intent. It is the intent of this local law to add Major Home Occupations as a Specially Permitted Use in residential zoning districts in the Town of Canandaigua.

SECTION TWO. The following text shall be added to Town Code § 220-18 as § 220-18(F)(9), immediately following § 220-18(F)(8), and immediately preceding § 220-19 (R-1-20 Residential District): "Major Home Occupations, as defined in Town Code § 1-17, and as further regulated by Town Code § 220-59."

SECTION THREE. The following text shall be added to Town Code § 220-19 as § 220-19(E)(6), immediately following § 220-19(E)(5), and immediately preceding § 220-20 (MR-Multiple Residence District): "Major Home Occupations, as defined in Town Code § 1-17, and as further regulated by Town Code § 220-59."

SECTION FOUR. Partial Invalidity. If any provision of this Local Law or the application thereof to any person or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unenforceable, such judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the provision, person, or circumstance directly involved in the controversy in which said judgment shall have been rendered.

SECTION FIVE. Effective Date. This Local Law shall take effect immediately upon filing with the New York State Secretary of State.
