RESOLUTION NO. 2017 – 272: AUTHORIZATION FOR SECURITY MEASURES AT TOWN HALL AND AUTHORIZATION OF USE OF REPAIR RESERVE FUND

WHEREAS, the Town Board of the Town of Canandaigua (herein after referred to as “Town Board”) wishes to install security measures at the Town Hall in order to protect the visiting residents, employees, and guests of the Town of Canandaigua; and

WHEREAS, the Town of Canandaigua in 2014 installed new electronic security access to the exterior of the Town Hall building through Colacino Industries; and

WHEREAS, Colacino Industries has met with the Safety and Security Committee to make recommendations for internal access utilizing the existing system throughout the Town Hall; and

NOW THEREFORE BE IT RESOLVED, the Town Board of the Town of Canandaigua hereby authorizes expenditures relating to safety and security measures including electronic control access at the Town Hall with Colacino Industries; and

BE IT FURTHER RESOLVED, the Town Board authorizes expenditures relating to emergency lockdown control in an amount not to exceed \$ 15,367.13 to be paid from General Fund A.1620.200; and

BE IT FURTHER RESOLVED, the Town Board authorizes expenditures relating to foyer entry access security control in an amount not to exceed \$ 13,862.42 to be paid from General Fund A.1620.200; and

BE IT FURTHER RESOLVED, the Town Board authorizes expenditures relating to main building access control for nine points at an amount not to exceed \$ 32,654.99 to be paid from General Fund A.1620.200; and

BE IT FURTHER RESOLVED, the Town Board authorizes the Town Manager and Bookkeeper to transfer \$ 15,367.13 from General Fund A.1620.400 (buildings contractual) to General Fund A.1620.200 (buildings capital); and

BE IT FURTHER RESOLVED, the Town Board authorizes the Town Manager and Bookkeeper to transfer \$ 46,517.41 from General Fund A.1990.400 (contingency) to A.1620.200 (buildings capital); and

BE IT FURTHER RESOLVED, the Town Board directs the Town Manager and Bookkeeper to prepare resolutions for the normally scheduled August Town Board meeting in order for the

Town Board to consider lowering the Repair Reserve Fund from \$ 155,000 to \$ 100,000 subject to permissive referendum; and

BE IT FINALLY RESOLVED, the Town Board directs the Town Clerk to provide a copy of this resolution to the Town Manager and Bookkeeper.
